Rec. 2 May 1771. She married (1) John Sealy III, born 1720-37, (son of John Sealy II and Hannah) died 1767, will signed 1767 in St. Luke's Parish, Granville County, SC,² <JOHN SEALY SR., St. Luke's Parish, Granville County, Planter. Wife: Susanna, 1/3 land where I now live called Swamp Plantation. Son: Joseph, under 21 years, residue of my lands. Nephews: Thomas and John Harrison, said land at death of my wife. Mentions land formerly belonging to Mr. Joseph Sealy, deceased, called Odinsel's Point to be sold to pay debts. Exors: wife; brother John Sealy Jr. {DEA note: brother"-in-law" named John, this could explain two John and John Sr. marrying his cousin Susanna}, Jr. Willoughby Pugh, Richard Guinn, Samuel; Watson.

"Pages 169-172. Petition of James Mackay and Susannah his wife late Susannah Sealy of Granville County, sheweth that John Sealy late of the same county and province, planter deceased, died owning a tract containing 900 acres known by the name of the Swamp Plantation in Granville County, and by his Will bearing date 17 Oct. 1767 bequeathed one third part of his said plantation tot eh said Susanah Mackay and the remaining two thirds to his son Joseph Sealy a minor under for years of age. Your petitioners are desirous of having the said plantation divided, and pray his Majesty's Writ of Partition. Commission to Daniel Heyward, John Heyward, Josiah Dupont, Gideon Dupont, and Cornelius Dupont commanding the desired division. Susannah Mackay is upwards of 21 years of age. 1769 (no day or month given). ... Commissioners' report dated 25 Sept 1769."

3. John Sealy, (1.Mr.¹) died 1773 in SC, will signed 28 Jul 1773 in St. Helena's Parish, Granville

County, SC,³ <John Sealy, St. Helena's Parish, Granville County. Wife Mary Bellinger, to live on my plantation during her widowhood. Dau. Elizabeth. Nephews: James Baggin Sealy, to be apprenticed out to a bricklayer at 14 years; Joseph Sealy, son of John [Sealy]. Niece: Dorcas Sealy, to be apprenticed to a mantua maker at 13 years. Mentions: children to be maintained and educated out of estate; Alexander Peronneau; unborn child; residue of estate to "all my children under age" Executors Thomas Rivers of Charles Town; Stephen Bull of Sheldon; John Bull at the Oakatee. Witnesses: D. Desausure; Edward Ellington; McKelsall. D. 28 July 1773, P. nd R. nd, page 40.>. This would explain John Sealy being the executor to his brother-in-law John Sealy (d. 1767 will 1767). This fits with John mentioning his nephew Joseph Sealy (son of John Sealy), again showing that the two John's were 1st cousins.

8. James Baggin Sealy, (4.Unk², 1.Mr.¹) born ca 1765 in SC, died ca 1795, occupation Bricklayer. Names in South Carolina, Vol XIX; winter 1972, page 51:
"Island planter James B. Sealy married on 14 May 1790 Mary Davant (1773-1806), eldest daughter of James and Lydia Davant, heiress to 200 acres of Lot 22 of Bayley's Barony at the head of Broad Creek, land later included in the Marshlands Plantation. Their two children were: Mary, born Sept. 1792, and James born Aug 1794 who married Elizabeth Stoney of the Otterburn family and was still planting on Hilton Head as late as the 1820 census. James B. Sealy died circa 1795, his widow marring George Kicklighter by whom she had three children, all born on Hilton Head: Ann, born Dec 1799, George, born 1804, and MARY who married her first cousin, William Irwin Fickling." He married Mary Davant, married 14 May 1790 in SC.
